#### Statement of Faith

## **Child Safety Policy**

**Objective:** Kids' Life Bible Clubs (KLBC), a non-denominational Christian ministry to school children, recognizes its' Biblical and moral imperative to protect the children attending it's Bible Clubs by establishing a policy to ensure a safe environment, free from physical, sexual, emotional or spiritual abuse and to protect our volunteers and staff by outlining high-risk activities when working with minor children.

**Definition of abuse:** Abuse is harm or threatened harm to a minor by a caregiver or someone in authority over the minor. Harm could be of a physical, sexual, emotional or spiritual nature.

**Policy:** KLBC strictly prohibits any physical, sexual, emotional or spiritual abuse. A volunteer or staff member who is accused of abuse, will be investigated by the civil authorities. The accused person will be suspended from his/her position with KLBC until allegations are either substantiated or dismissed by civil authorities. If a staff member is accused, she/he will continue to receive pay while being investigated. If allegations are substantiated, the volunteer or staff member will be permanently removed from his/her position with KLBC. If the allegations against the volunteer or staff member are dismissed the Board of Directors will determine whether or not she/he is reinstated to her/his position with KLBC.
